**Subject of the Disclosure**

Conversion of Shareholder's Advances in Emerging Power Inc. to additional Equity.

**Background/Description of the Disclosure**

The Company on 22 December 2017, pursuant to a previously disclosed Resolution issued by the Board of Directors on 04 August 2017, entered into a Deed of Assignment with its subsidiary, EMERGING POWER INC. (EPI), for the assignment of its advances in EPI in the total amount of ONE BILLION FIVE HUNDRED MILLION PESOS (Php1,500,000,000.00) following a Capital Call made by EPI.

In consideration for such assignment, EPI shall, subject to the approval by the Securities and Exchange Commission of an increase in EPI's Authorized Capital Stock, issue ONE BILLION ONE HUNDRED NINETY MILLION FOUR HUNDRED SEVENTY SIX THOUSAND ONE HUNDRED NINETY (1,190,476,190) shares in favor of the Company therefore increasing the Company's equity in EPI to NINETY ONE PERCENT (91%).
