With regard to our disclosure on April 22, 2026, Nickel Asia Corporation (the "Company") discloses today, June 3, 2026, that it has obtained approval of the Board of Directors to make an initial payment to Silk Road Resources Ltd., a private company incorporated under the laws of Astana International Financial Centre, Astana, Kazakhstan, in the amount of USD10 Million, following the completion and satisfactory results of its due diligence on East Copper Production LLP ("East Copper") and GRK MLD LLP, pursuant to the Membership Interest Sale and Purchase Agreement ("SPA") for the acquisition of a 20% membership interest (share in contribution) in East Copper. The closing of the transaction remains subject to the completion of other closing conditions under the SPA and necessary regulatory approvals.

In furtherance of our disclosure on February 25, 2026, the Company has completed the incorporation of its wholly-owned subsidiary in Singapore, NAC Global Investments Pte. Ltd., which is intended to hold the Company's international investments, including all rights and interests of the Company under the SPA.
